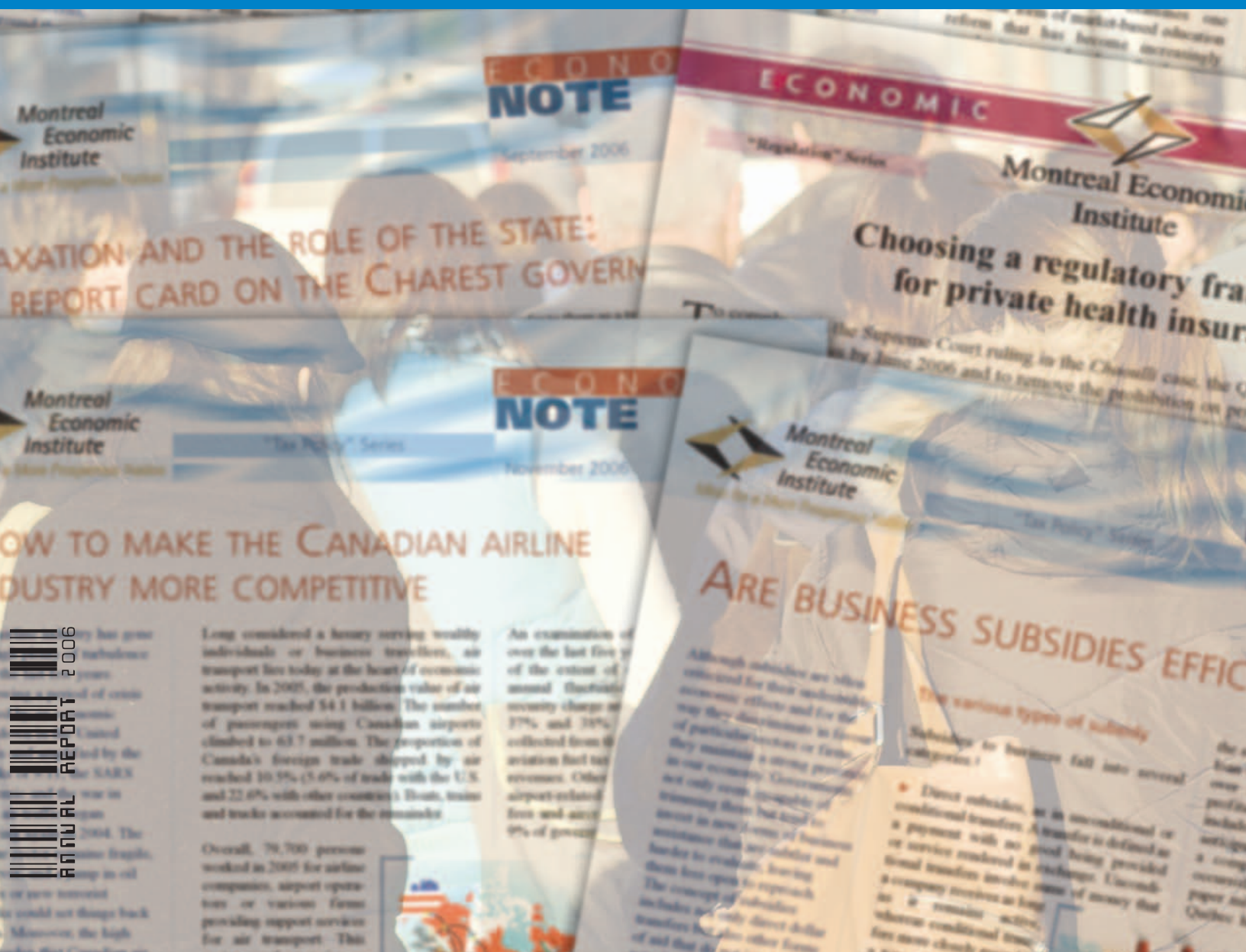

Long considered a luxury serving wealthy individuals or business travellers, air transport lies today at the heart of economic activity. In 2005, the production value of air transport reached \$4.1 billion. The number of passengers using Canadian airports climbed to 63.7 million. The proportion of Canada's foreign trade shipped by air reached 10.5% (5.6% of trade with the U.S. and 22.6% with other countries). Boats, trains and trucks accounted for the remainder.

Overall, 79,700 persons worked in 2005 for airline companies, airport operators or various firms providing support services for air transport. This

# PRESIDENT'S MESSAGE

**T**he Montreal Economic Institute aims through educational work to enhance the general public's understanding of economic phenomena. We promote the adoption of public policies motivated by economic logic with a focus on wealth creation.

The effectiveness of a think tank such as the MEI can be assessed by means of three criteria. First, by seeing to what extent it reaches the public, especially via the media. Second, by gauging the resonance created by its ideas. Are its arguments being taken up elsewhere? Is its work being quoted? Are its researchers invited to speak at other forums? Third (and this is the most demanding criterion), by seeing how far public policy is really changing in the direction of ideas advanced by its researchers. By each of these three criteria, the MEI is truly an effective think tank.

## GROWTH IN THE DISSEMINATION OF IDEAS

The Institute has again benefited from broad media coverage. Some 1,623 articles and news reports mentioned the Institute in 2006, compared to 1,350 a year earlier. This is a 20% rise.

With close to a million unique visitors in 2005-06, nearly triple the number in the previous period, our bilingual website is reaching an impressive audience in Quebec and around the world.

Our media visibility is extensive, not only in its magnitude but also in its

geographic range and quality. Some of our publications have had an effect across Canada. More than 130 opinion pieces signed by our researchers were published in daily papers and specialized magazines. We have had a regular presence, more than once a month, in Canada-wide newspapers such as the *National Post*. Institute representatives signed more than 15 columns in the weekly business paper *Les Affaires*.

With the publication of her book *La face cachée des politiques publiques* (The Hidden Face of Public Policy), our economist Nathalie Elgrably became a true media phenomenon. She continues her weekly column on public policy issues each Thursday in *Le Journal de Montréal*, Quebec's most widely read newspaper, as well as in *Le Journal de Québec* in Quebec City. She is invited on a regular basis to give her opinion on public affairs programs produced by various broadcasters. Few think tanks anywhere in the world are able to reach the general public as directly and regularly through major channels such as these.

We should also point out that the MEI achieved another distinction in 2006: *Le Trente* magazine, published by Quebec's federation of professional journalists, spitefully ranked it among the five most overexposed sources in Quebec.

## PRESIDENT'S MESSAGE

### INFLUENTIAL PUBLICATIONS

The year 2006 marked a major step in questioning the famous “Quebec model”. The Institute contributed to this ideological renewal by informing the public of Quebec’s true economic situation and the wealth-creating policies it could adopt.

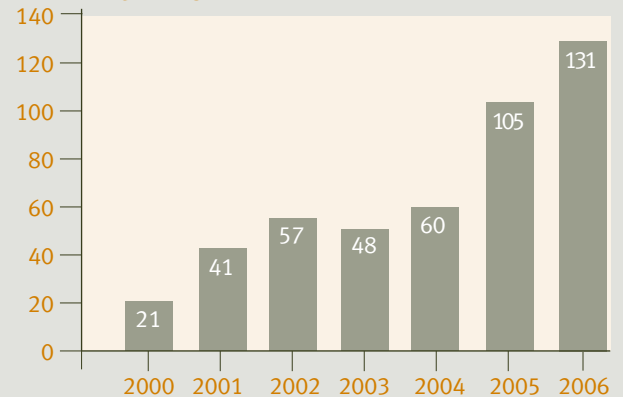
Among our contributions, we can point to a study by our economist Norma Khozaya on Quebec’s relative poverty in North America. Her Economic Note on this topic nourished doubts regarding the notion that Quebec is more egalitarian than its neighbours. The central argument in this study was taken up by numerous observers, including columnist Alain Dubuc in *La Presse*.

Our propensity to challenge commonly accepted ideas also brought us into the field of transport and housing in the Montreal metropolitan area. A Research Paper prepared by our associate researcher Wendell Cox concluded that Montreal is more

GROWTH IN THE NUMBER OF OPINION PIECES PUBLISHED BY THE MEI IN NEWSPAPERS AND MAGAZINES

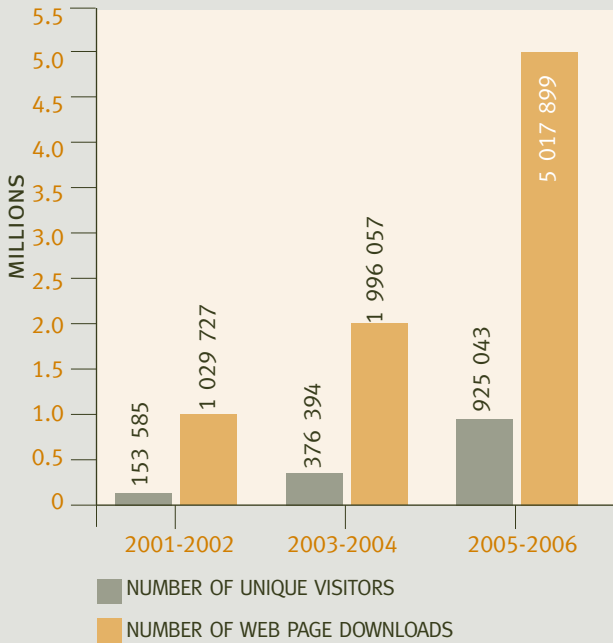


competitive because of its suburban development. This study enabled us later to intervene in favour of a project to extend Highway 25.

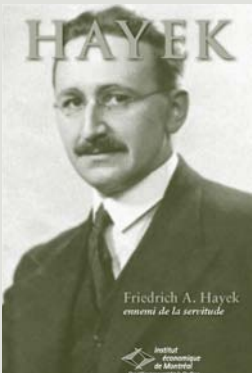
In the area of social policy, another Economic Note signed by Norma Khozaya dealt with the Quebec system of subsidized childcare, supposedly more universal and equitable than the previous system of parental assistance. Our study showed that, on the contrary, the current system is becoming increasingly expensive and heavily restrains the options available to thousands of families. The alternative approach suggested in this Note has been adopted by one of the three main political parties on the provincial scene.

In September, a study signed by former executive vice-president Tasha Kheiriddin examined the Quebec government’s efforts to lighten taxes and the burden of government. The study found that little had been achieved compared to the government’s initial promises, and it

**GROWTH IN THE NUMBER OF WEBSITE VISITORS**



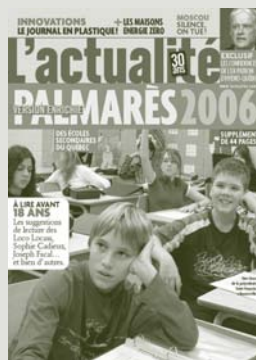
generated extensive media coverage. The study's conclusions were hotly challenged by the premier and two other government ministers, until a number of columnists, including Alain Dubuc and Claude Picher of *La Presse*, said the author was correct.

As it has done each year since 2000, the Institute issued its annual Report Card on Quebec's Secondary Schools in collaboration with the Fraser Institute, with 2006 marking the seventh edition. Thanks to our media partnership with *L'Actualité* magazine, it reached more than a million parents, students and people in the education field. Reporting by journalists with *L'Actualité* helped bring the Report Card's raw numbers to life. This publication has become an

indispensable reference tool for parents seeking to be knowledgeable in the choice of their children's school or showing interest in the quality of education provided. This exercise also helps establish a culture of choice and responsibility in Quebec.



In addition to these dossiers, 14 other publications, not counting translations, marked a very productive year in fields including the debt, subsidies to business, management of automobile insurance and

flexibility of the labour market. They are all listed in this report and can be downloaded free of charge from our website.

Finally, let us note that our 2005 study on privatization of the Société des alcools du Québec kept the ink flowing in 2006. A number of editorialists and columnists praised the study's quality and relevance. This shows unmistakably that we can influence various areas of debate and public opinion when we rely on rigorous, well documented research.

**PRIVATE HEALTH INSURANCE: THE INSTITUTE HAS HELPED GET REFORM STARTED**

The MEI has aimed since 2001 to inform the public on the limits of our monopoly system and to propose alternatives that rely on market mechanisms. In 2006, in the wake of

the Supreme Court ruling in the Chaoulli case, the Quebec government introduced Bill 33 eliminating the government health insurance monopoly with respect to three surgical procedures.

In preparation for the bill, the Institute published in 2006 an Economic Note on a model that the Supreme Court ruling anticipated, namely duplicate insurance covering all health care. We then presented a brief to the National Assembly showing the advantages of establishing a regulatory framework that would eliminate Quebec's public health insurance monopoly and enable Quebecers to benefit fully from the development of new private insurance.

In October, the MEI ordered its third cross-Canada opinion poll on Canadian attitudes toward the private sector in health care. This poll revealed that two people out of three in Quebec would favour the Quebec government opening access to private health insurance for all medically required care already covered by the public system. These polls are an effective complement to our studies in raising the interest of media and decision-makers.

Through its actions on this issue over the years, the MEI is proud to have contributed to Quebec adopting an initial reform curtailing the public monopoly on health insurance.

## NOTEWORTHY EVENTS AND DEBATES

In 2006, the Montreal Economic Institute organized nine events enabling members of the public to hear and meet opinion leaders. This included a talk by Claude Ruey, leader of the Swiss Liberal Party, who spoke of his country's health care system before more than 200 persons. This speech provided a clearer understanding of the private sector's potential role in financing the health care system and providing services.

Another noteworthy speech was given by Len Shackleton, dean of the Westminster Business School, on reforms undertaken in Britain by Margaret Thatcher, the decline of unions and the surge of the British economy. The Thatcher period was also the topic of a speech by Madsen Pirie, president of the Adam Smith Institute of the U.K., at a dinner at Toronto's Empire Club.



In December 2006, for the second time, the Institute held the Jean A. Pouliot lecture, named after one of our earliest supporters and sponsored by his family. Pascal Salin, professor of economics at Université Paris-Dauphine and former president of the Mont Pelerin Society, spoke eloquently of tax competition at the international level.

The MEI is also increasingly present in specialized fields. We held 13 events for students, the opinion leaders of tomorrow. Our researchers also gave 31 talks in events organized by third parties such as the Association of Apartment Owners of Greater Montreal.

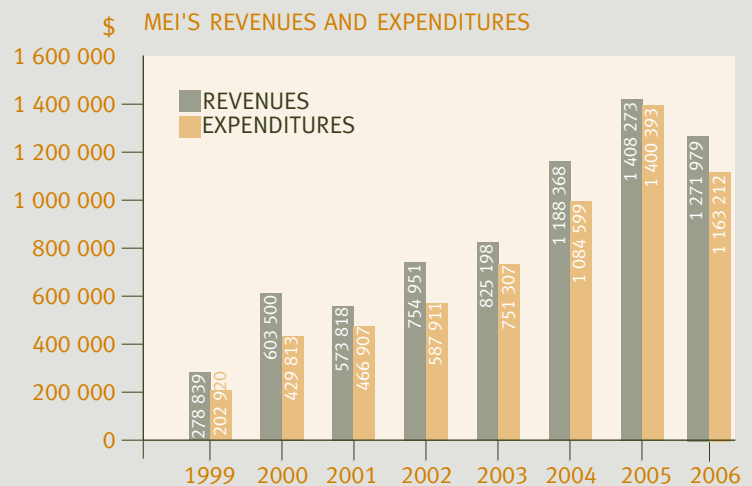
### A SOUND FINANCIAL SITUATION

The MEI is financed entirely through donations from individuals, businesses and foundations, through the sale of its publications, and through sponsorships and entry fees to events it holds. To maintain its independence, the MEI does not receive or solicit public funds and seeks to diversify its sources of financing.

In 2006, our financial situation has remained healthy. Income came to \$1,271,979, down 10% from the previous year in a context of transition between the former and new presidents. Spending also declined, falling to \$1,163,212, down 17% from 2005. The 2006 fiscal year ended with a

surplus of \$108,767. Our accumulated surplus stands at \$830,545, a modest amount though still adequate to ensure our stability and independence. This financial independence enables the Institute to speak out freely on any issue of public policy. In this way it serves the greatest numbers of people, namely consumers and taxpayers.

Continued support from our donors, sponsors and subscribers to our publications is, of course, essential to the Institute's existence and progress. We offer warm thanks to these people and entities, and we urge them to renew their support in 2007. The Institute also has the good fortune to count on a highly professional and motivated staff whose commitment we are pleased to salute.
